To the best of our knowledge the chemical, physical and toxicological properties of zirconium boride have not been thoroughly investigated and recorded.

Zirconium compounds are not an important industrial poison. Most zirconium compounds in common use are insoluble and considered inert. Pulmonary granuloma in zirconium workers has been reported. (Sax, Dangerous Properties of Industrial Materials, eighth edition)

Boron compounds are very toxic and therefore considered an industrial poison. Boron is one of a group of elements, such as Pb, Mn, As, which effects the central nervous system. Boron poisoning causes depression of the circulation, persistent vomiting and diarrhea, followed by profound shock and coma. The temperature becomes subnormal and a scarletina form rash may cover the entire body. (Sax, Dangerous Properties of Industrial Materials, eighth edition)

Signs and Symptoms of Overexposure:

Inhalation: May cause red, dry throat, coughing, sneezing and difficulty breathing. Boron poisoning may cause: depression of the circulation, persistent vomiting, diarrhea, shock and coma.

Ingestion: May cause burning sensation. Boron poisoning may cause: depression of the circulation, persistent vomiting, diarrhea, shock and coma.

Skin: May cause redness, burning sensation and itching.

Eye: May cause redness, itching, burning sensation and watering.

Health Hazards (Acute and Chronic):

Inhalation:

Acute: May cause irritation to the respiratory tract, mucous membranes, nose and throat and boron poisoning.

Chronic: No chronic health effects recorded.

Ingestion:

Acute: May cause irritation to the gastrointestinal tract and boron poisoning.

Chronic: May affect the central nervous system.

Skin:

Acute: May cause irritation.

Chronic: May cause dermatitis and skin granulomas.

Eye:

Acute: May cause irritation.

Chronic: No chronic health effects recorded.

Target Organs: May affect the skin, respiratory and central nervous system.

Medical Conditions Aggravated by Exposure: Pre-existing respiratory disorders.

Emergency and First Aid Procedures:

Inhalation: Remove victim to fresh air, keep warm and quiet, and give oxygen if breathing is difficult; seek medical attention

Ingestion: Give 1-2 glasses of milk or water and induce vomiting, seek medical attention. Never induce vomiting or give anything by mouth to an unconscious person

Skin: Remove contaminated clothing, brush material off skin, wash affected area with mild soap and water, and seek medical attention if symptoms persist

Eye: Flush eyes with lukewarm water, lifting upper and lower eyelids for at least 15 minutes and seek medical attention

SECTION VII - PRECAUTIONS FOR SAFE HANDLING AND USE

Steps to be taken in case material is released or spilled:

Wear appropriate respiratory and protective equipment specified in section VIII. Isolate spill area, provide ventilation and extinguish sources of ignition. Vacuum up spill using a high efficiency particulate absolute (HEPA) air filter and place in a closed container for proper disposal. Take care not to raise dust.

Waste disposal method:

Dispose of in accordance with state, local, and federal regulations.

Hazard Label Information:

Store in cool, dry area and in tightly sealed container. Wash thoroughly after handling.
